- Valid identification on all signers

- Articles of Incorporation, By-laws, Code of Regulations, Charters and/or Constitutions (stating who has authority to manage financial deposit accounts)
- Valid identification on all signers
- Beneficial Ownership Information Report (BOIR) Transcript from FinCEN registration
